### **K12 Summer Games Rewards Program: Terms and Conditions**

Welcome to the K12 Summer Games Rewards Program (the "Program")! Please read these terms and conditions (the "Terms") to understand how you can participate in the Program and earn coins for prizes.

BY PARTICIPATING IN THE K12 SUMMER GAMES REWARDS PROGRAM, EACH PARTICIPANT REPRESENTS AND WARRANTS THAT THEY MEET THE ELIGIBILITY REQUIREMENTS DETAILED WITHIN THE TERMS AND ACKNOWLEDGES THAT FAILURE TO MEET ALL ELIGIBILITY REQUIREMENTS MAY RESULT IN REMOVAL FROM THE PROGRAM AND FORFEITING EARNED COINS. PARTICIPATION IN THE PROGRAM CONSTITUTES YOUR ACCEPTANCE OF THE TERMS.

# Eligibility

The Program is only open to students in grades K–12 enrolled in a K12-powered school who are legal residents of the 50 United States and the District of Columbia. "Participants" means students eligible to participate in the Program. The Program is subject to all applicable federal, state, and local laws and regulations.

### How to Participate in the Program

Eligible students can participate in the Program by accessing the K12 Skills Arcade based on courses loaded to their OLS platform. K12 Skills Arcade is an award-winning learning solution that automatically adapts to your student's skill level and helps them grow at their own pace. Students answer questions that test their knowledge in reading, math, English language arts, and science and play fun games as a reward for the skills they've developed.

#### **Welcome Coins**

All students will receive 2,000 welcome coins that can used to participate in the Program. Welcome coins and any additional coins earned can be viewed on the K12 Skills Arcade leaderboard.

#### **Earning Coins**

You can earn additional coins by completing qualifying activities listed within K12 Skills Arcade and as determined by Stride.

The number of coins you can earn for each activity will be listed on the leaderboard within Skills Arcade.

#### **Tracking Coins**

You can track the number of coins you have earned by logging into your OLS account and visiting Stride Skills Arcade via your Brain Boost course.

# **Redeeming Coins for Prizes**

On or about October 1, 2024, we will send you an email notification with information regarding the prize you are qualified to receive based on the total number of coins accrued as of 11:59 PM (ET) on September 30, 2024.

The total number of coins required for each prize will be specified in the K12 Skills Arcade.

# **Program Dates**

This Program starts on June 10, 2024, and ends September 30, 2024.

#### **Prizes**

To collect prizes, Participants may be required to complete and return a notarized Affidavit of Eligibility and Liability and, where permissible, a Publicity Release ("Affidavit/Release") within seven days of date specified on notification. If an Affidavit/Release and/or if any required document(s) is not returned within such time, or if a Participant cannot accept or receive the prize for any reason, or if they are not in compliance with these Terms, the prize will be forfeited as determined by Stride in its sole discretion. Participants assume all liability for any injury, including death or damage caused or claimed to be caused, by participation in this Program or use, redemption, or acceptance of any prize.

This Program shall be governed by and interpreted under the laws of the Commonwealth of Virginia, U.S., without regard to its conflicts of laws provisions. Participant hereby agrees that any and all disputes, claims, causes of action, or controversies ("Claims") arising out of or in connection with this Program shall be resolved, upon the election by Participant or Stride, by arbitration pursuant to this provision and the code of procedures of either the NATIONAL ARBITRATION FORUM ("NAF") OR THE AMERICAN ARBITRATION ASSOCIATION ("AAA"), AS SELECTED BY THE PARTICIPANT. IF ARBITRATION IS CHOSEN BY ANY PARTY WITH RESPECT TO A CLAIM, NEITHER PARTY WILL HAVE THE RIGHT TO LITIGATE THAT CLAIM IN COURT OR HAVE A JURY TRIAL ON THAT CLAIM. FURTHER, NEITHER STRIDE NOR PARTICIPANT WILL HAVE THE RIGHT TO PARTICIPATE IN A REPRESENTATIVE CAPACITY ON BEHALF OF THE GENERAL PUBLIC OR OTHER PERSONS SIMILARLY SITUATED, OR AS A MEMBER OF ANY CLASS OF CLAIMANTS PERTAINING TO ANY CLAIM SUBJECT TO ARBITRATION. EXCEPT AS SET FORTH BELOW, THE ARBITRATOR'S DECISION WILL BE FINAL AND BINDING. NOTE THAT OTHER RIGHTS THAT PARTICIPANT WOULD HAVE IF PARTICIPANT WENT TO COURT ALSO MAY NOT BE AVAILABLE IN ARBITRATION. The arbitrator's authority to resolve Claims is limited to Claims between Stride and Participant alone, and the arbitrator's authority to make awards is limited to awards to Stride or Participant alone. Furthermore, Claims brought by either party against the other may not be joined or consolidated in arbitration with Claims brought by or against any third party unless agreed to in writing by all parties. No arbitration award or decision will have any preclusive effect on issues or claims in any dispute with anyone who is not a named party to the arbitration. Notwithstanding any other

provision in this Agreement, and without waiving either party's right to appeal such decision, should any portion of this provision be deemed invalid or unenforceable, then the entire provision (other than this sentence) shall not apply. Stride is not responsible for any typographical or other error in the printing of the offer, administration of the Program, or in the issuance of any prize.
